Particulars of its organization, functions and duties


1) Back ground:

The Karnataka State Warehousing Corporation was established during the year 1957 under the agricultural produce (Development and Warehousing) Corporation Act 1956, later repealed by the Warehousing Corporation Act-1962. The Government of Karnataka and the Central Warehousing Corporation are the two shareholders of the Corporation having 50:50 basis equity shares.

### 3) Activities and Duties.

- To Construct and manage warehouse in the state for the storage of agricultural produces, seeds, manure, fertilizers, agricultural implements and other notified commodities and preserve them scientifically.
- To enhance the storage capacity by procuring land and constructing godowns at potential places to fill the gap of storage space in the state.
- To support public Distribution System in the state through proper storage and up-keeping.

Powers and Duties of its Officers

- 1) The duties of the Officers and the employees of the Corporation is furnished below:

**I : MANAGING DIRECTOR**

- i) To maintain the Administration of the Corporation as per the Karnataka State Warehousing Corporation Act, 1961 Rule 1969.
- ii) To maintain daily administration, to implement Board decisions as per Rules of the Corporation.
- iii) To call Board Meeting from time to time and of the Corporation and take action to introduce new project and policy Rules.
- iv) With the Coordination of the Board of the Corporation, Government and the field level will be the priority for the implementation of the work.
- v) The need for advice to Corporation employees is to take necessary steps to ensure their wellbeing.
- vi) To implement the Act-columns underlying Corporation work.
- vii) Overall monitoring of general administration of the Corporation.
- viii) Giving promotions to the employees and to take disciplinary action in necessary occasions.

**II. CHIEF VIGILANCE OFFICER**

- i) Acting strictly in accordance with the directions of the Managing Director.
- ii) Processing of cases of complaints on Fraud, Theft, Misappropriations, Fire, Burglary etc., received from the Regional Managers and from other sources.\
- iii) Investigations, Formalities and recommending to the Disciplinary Authority i.e. the Managing Director with in the frame work of Rules of the Corporation.
- iv) Intensive Tours to make periodical checks of Cash Balances.
- v) Submission of detailed report of Vigilance Cases to the Managing Director.
- vi) His work jurisdiction is state jurisdiction.

**III. SECRETARY**

- i) Arrangements regarding the meetings of BOARD, EXECUTIVE COMMITTEES and other sub/committees. The receipt of Agenda and timely Dispatch of the same to Directors and smooth conduct of Meetings.
- ii) Record of the Proceedings of the Meetings after the Meeting, findings of Proceedings after approval of the concerned authority.
- iii) Maintenance of Registers of the Proceedings of the Board Meeting as well as Executive Committee Meeting.
- iv) Should Work in the Head Office.

#### **IV. ADMINISTRATIVE OFFICER**

- i) Maintenance of Rules & Regulations amendment, of Rules and Regulations, issuing of instructions from time to time.
- ii) Tappals will be opened and sent to the Managing Director.
- iii) Diaries of OFFICERS will be maintained.
- iv) Maintaining & monitoring the Movement of Corporation Vehicles including maintenance of Log Books.
- v) Supply of Stationery and printed Forms from Head Office to the field and maintenance of Dead Stock Register.
- vi) Maintenance and updating of Service Registers of all employees of Corporation and submitting Confidential Reports to The Managing Director.
- vii) Maintenance of overall discipline of Class II, III & IV employees and Better labour relations.
- viii) All Service matters of the employees.
- ix To undertake State Jurisdiction tour on the instructions of the Managing Director.

#### **V. GENERAL MANAGER (T&QC)**

- i) Prompt action for DES & Fumigation whenever /wherever necessary.
- ii) A Close watch over consumption of Chemicals to make available the - Chemicals whenever needed.
- iii) Providing dunnage whenever needed to avoid losses/damage to stocks.
- iv) Ensure proper stacking in stack plans drawn in every Centre.
- v) Ensuring hygiene at all Centers and maintaining Scientific method of stacking.
- vi) Maintenance of all equipment's for maintenance of stocks in serviceable points
- vii) Stamping & verification of weighing scales/weighbridge.
- viii) To undertake State Jurisdiction tour on the instructions of the Managing Director.

#### **VI. GENERAL MANAGER (COMMERCIAL)**

- i) Matters relating to Expansion and Diversification of Activities of the Corporation.
- ii) Fixing Storage Charges, Studying the costing and suggesting improvement in the Economics of Warehousing.
- iii) Cases relating to the Policy & Procedures regarding work staffing, according to the workload and other allied problems (that may arise) of the Corporation.
- iv) Keep a watch on the Economy and physical performance of each center.
- v) Ensuring that the Regional Managers & Warehouse Managers discharge their duties efficiently.
- vi) Maintenance of statistics regarding availability of Storage capacities with various agencies.

## **VII. GENERAL MANAGER, DEPUTY GENERAL MANAGER, DEPUTY MANAGER (ACCOUNTS)**

- i) All Financial aspects, Budget and Budgetary Control.
- ii) IT, PT & ST Cases of employees.
- iii) Fund Investment.
- iv) Bank Reconciliation of Head Office & Branches.
- v) Realization of old pending Storage Charges & H&T.
- vi) Payment of PAY BILLS, TA BILLS of employees of Corporation.
- vii) Maintenance of General Ledger for Income and Expenditure Accounts.
- viii) Safe custody of share Certificates, Securities and other documents.
- ix) Preparations of Budget, Annual Account and Balance Sheet of the Corporation.
- x) Claiming Bills and collections of outstanding Bills from Customers regularly and updating the same.
- xi) Should Work in the head office.

## **VIII. DEPUTY GENERAL MANAGER (AUDIT)**

- 1 He shall be responsible for taking up Internal Audit of warehouses and Head Office.
- 2 He must undertake tour for a minimum of 15 days in a month compulsorily and get his time programme approved by the Managing Director.
- 3 During his visit to warehouses to conduct audit the following items of work should be attended to-
  - i) Immediately after his arrival/at the warehouse he should verify the cash book and tally the cash on hand and certify in the register.
  - ii) He should physically verify the stocks in each godown and tally it with the stock register in warehouse and respective godowns. He should also certify in the stock register.
  - iii) He should verify the stocks of Insecticides and mention in the report whether balance is struck every time the Insecticides are made use of.
  - iv) He should verify the godown register of rent paid to the parties every month regularly.
  - v) He should verify the insurance register.
  - vi) He should test check the weighment in each stack in each of the godowns by selecting at random and certify the weight in the stock register giving the details of stack No. and line from which the test weighment bag was drawn and the weight.
- 4 The defects found during his audit should be immediately reported to the Head Office.
- 5 Audit reports should be sent by him after observing all the above formalities immediately after the audit is completed, from each center visited. Reports should be sent in half margin notes with the compliance of the warehouse Manager on all items which could be got by them in their presence & for receiving items which could be got by them in their presence and for receiving items which require time. The warehouse Manager should be instructed to send it within a week.
- 6 The tour programme of the Deputy Manager (Audit) shall be drawn in such a manner as to cover all the warehouses in all the divisions every year.

## **IX. ASSISTANT EXECUTIVE ENGINEER**

- i) Construction of New/Additional Warehouses and maintenance of Warehouses and Head Office Building.
- ii) Preparations of Plans/Estimates etc., for new Warehouses/Additional Warehouses/ Annual Repairs work and Sundry works as provided by the Board.
- iii) Supervising of all works, checking. Measuring and submission of Bills to the Managing Director.
- iv) Correspondence regarding Purchases of Land, constructions of Warehouses & Execution of Sale Deed.
- v) Limited to State wide Warehouse Centers

## **X. REGIONAL MANAGER**

- i) Close supervision over the work of Warehouses In-charge and watch over Their Activities.
- ii) Finding out the causes for decrease in the business of various centers and to Suggest ways to improve the business.
- iii) Propaganda/Publicity, holding Meeting to attract more business.
- iv) Maintain contact with the Depositors of his Region and with the Chief of APMC/ Office and Food and Civil Supplies/D.C and all Departments concerned
- v) Follow-up and collection of outstanding dues (Storage Charges /Fumigation Charges) from Depositors/Companies etc.,
- vi) To ensure proper supply of Chemicals to Centers to avoid shortage of supply of Chemicals and necessary timely fumigation.
- vii) Collections of Marketing Information.
- viii) To hold Meeting/discussions with Warehouse In-charges in his Regions to over Come the difficulties faced by Warehouses Managers and Depositors.
- ix) Overall supervisions of Region for smooth conduct of Transactions.
- x) Regular inspection/Audit of Warehouses in his Region, and ensure proper Follow up action.
- i) Having a Guidelines for the economic future.
- ii) Improving Corporation financial performance and directing the operations of the Corporation. Maintaining accounting records, ensuring compliance with regulations, supervision of accounting, analyzing Financial Data, ensuring accuracy of audit procedures and coordination of information.
- iii) Maintaining a positive income and shaping economic growth. Enforcing proper internal controls. Achieving organizational goals and developing financial plans that support the corporation strategy.
- iv) Supervision of the various Centers of the Corporation and control and submission of various periodical reports to the Board.
- v) Supervision of internal controls.

- vi) Preparation of Income statement and supervision.
- vii) Different budget projects and formulate and implement work procedures and constantly monitoring and reporting the actions to the Board where necessary.
- viii) Managing financial transactions.
- ix) Streamlining of accounting functions and operations.
- x) Developing plans for economic growth.
- xi) Evaluation and risk management.
- xii) Coordinate auditing processes.
- xiii) The scope of the Regional Manager is limited to respective Region.

## **XI. WAREHOUSE MANGER**

- i) Deposit of Goods & issue of Warehouse receipts.
- ii) Maintenance of goods in hygienic conditions, free from dampness and leakagto prevent loss/damage while in storage.
- iii) He shall accept all agricultural Produces without any discrepancies.
- iv) He shall insure all goods accepted.
- v) He should release the stocks accepted for storage whenever the depositors Demands.
- vi) He shall write all Books and Registers.
- vii) He shall keep the Warehouse open during the business hours as per Rule No.40 of The Karnataka Warehouse Rules. 1967.
- viii) He shall not mix two different unlike commodities like Fertilizers and Food Grains.
- ix) The Commodities pledged with the bank should not be delivered to the depositors Unless instructed by the banks.
- x) Warehouse Managers are responsible for stocks, cash, records, equipment's and all other properties of the Corporation.
- xi) He shall, write the cash book every day after the close of that day
- xii) He is responsible for publicity and propaganda in attracting business and Keep the Centers under profit.
- xiii) All returns/reports/statements of all the companies to be submitted on time.
- xiv) Maintaining cordial relations with all the depositors.
- xv) Any other work entrusted by the Managing Director.
- xvi) The scope of the Warehouse Manager is limited to the Warehouse Centre concerned.

## **X : FINANICAL ADVISOR**

- i) To have a roadmap for Corporation financial future.
- ii) To improve our Corporation's financial performance and direct Corporation operations, managing accounting records, evaluating and managing risk, ensuring compliance with regulations, overseeing accounting operations, analyzing financial data, monitoring expenditure, forecasting revenue, coordinating auditing processes, and ensuring accuracy of financial information.
- iii) Maintaining positive revenue and financial growth formulating sound financial strategies, implementing proper internal controls, achieving Organizational targets, and developing financial plans that support Organizational strategy.
- iv) To monitor and control the various branches of Corporation and to submit various periodical reports to the Board.
- v) Monitoring internal controls.
- vi) Overseeing and preparing income statements.
- vii) To formulate, implement, and constantly monitor various budgetary plans and procedures and to report to the Board in cases where actions are required.
- viii) Managing financial transactions.
- ix) Streamlining accounting functions and operations.
- x) Developing plans for financial growth.
- xi) Evaluating and managing risk.
- xii) Coordinating audit processes.

- 1) The Board and Executive Committee are the decision making bodies of the Corporation All sections of the Corporation will execute the orders of the Board/Executive Committee depending on the sections involved.
- a) The supervision of the implementation of the decisions of the Board/EC are done by Heads of the Sections and in turn the overall supervision is done by the Managing Director.
- b) All the section heads are accountable to the Managing Director and the Managing Director in turn to the Board and Executive Committee.

A Statement of the Boards, Council, Committees and other bodies consisting of two or more persons constituted as its or for the purpose of its advise, and as to whether meetings of those boards, council, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public

Information regarding Board Meetings:

- 1) As per the Chapter III, Section 20(1) of the Warehousing Corporation Act 1962, the general superintendence and management of the affairs of a State Warehousing Corporation shall vest in a Board of Directors which shall consist of the following, namely:
  - (a) Five directors nominated by the Central Warehousing Corporation of whom one shall be nominated in consultation with the State Bank and one at least shall be a non-official:
  - (b) Five directors nominated by the State Government: and
  - (c) A managing Director, appointment by the State Government in consultation with the directors referred to in clauses (a) and (b) and with the previous approval of the Central Warehousing Corporation.
- 2) The Chairman of the Board of Directors shall be appointed by the State Government from among the directors of the State Warehousing Corporation with the previous approval of the Central Warehousing Corporation.
- 3) The Managing Director shall:
  - a) Exercise such powers and perform such duties as the Directors or the State Warehousing Corporation may entrust or delegate to him: and
  - b) Receive such salary and allowances as the State Warehousing Corporation, and with the previous approval of the State Government, fix.
- 4) The Board of directors shall act on business principles having regard to public interest and shall be guided by such instruction on questions of policy as may be given to them by the State Government or the Central Warehousing Corporation.

Information regarding Executive Committee Meetings:

- 1) There shall be an Executive Committee of State Warehousing Corporation which shall consist of-
  - a) The Chairman of the Board of Directors
  - b) The Managing Director :and
  - c) Three other Directors chosen in the prescribed manner of whom one shall be a Director referred to in clause (a) of sub-section (1) of section 20.
- 2) The Chairman of the Board of Directors shall be the Chairman of the Executive Committee.
- 3) Subject to any general or special Directors as the Board of Directors may, from time to time, give, the Executive Committee shall be competent to deal with any matter within the competence of the State warehousing Corporation.

The minutes of the Board and Executive Committee Meeting are accessible to the public on the basis of requests made by the individuals.

A Joint Committee is formed for appointment of Contractors for Construction of Godowns/Handling and Transportation and purchases of Chemicals which consists of following.

- 1) Managing Director
- 2) Administrative Officer
- 3) General Manager
- 4) Deputy General Manager (Accounts)
- 5) Assistant Executive Engineer
