(Karnataka Act 11 of 1963), is here by published as required by sub-section (1) of section 74 of the said act, for the information of the persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration after thirty days from the date of its publication in the Official Gazette.

- 1. Title and commencement.- (1) These rules may be called the Karnataka Planning Authorities(Allotment of Civic Amenity Sites) (Amendment) Rules, 2020.
  - (2) They shall come into force from the date of their publication in Official Gazette.

Whereas, the draft of the following Rules further amend the Karnataka Warehouses(Alternation of the Schedule)Rules, 2020 was published as required by sub-section(1) of said section of the Karnataka Warehouses Act, 1961(Karnataka Act 11 of 1962) in Notification No. CO 52 WHC 2019, dated: 09-10-2020 in Part IV-A(No.384) of the Karnataka Gazette Extra-ordinary dated: 22-10-2020 inviting

objections and suggestions from persons likely to be affected there by within thirty days from the date of publication of draft in the official Gazette.

Whereas, the said Gazette was made available to the public on 22<sup>nd</sup> October 2020.

And, whereas no objections and suggestions have been received by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section(2) of section 34 of the Karnataka Warehouses Act, 1961(Karnataka Act 11 of 1962), the Government of Karnataka makes the following rules, namely:-
